AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF BRANTLEY OAKS SUBDIVISION

THIS AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS OF BRANTLEY OAKS SUBDIVISION is made this the <u>I</u> day of <u>January</u>, 2015, by Brantley Oaks Homeowners Association of Union County, Inc., (hereinafter referred to as the "Association.")

WITNESSETH:

WHEREAS, the Declarant, Waxhaw Development Group II, LLC, subjected Brantley Oaks Subdivision (the "Property") to the Declaration of Covenants, Conditions, and Restrictions of Brantley Oaks Subdivision (the "Declaration"), recorded in **Book 1066**, **Page 764** of the Union County Register of Deeds.

WHEREAS, the Declaration and all the definitions contained therein are incorporated herein:

WHEREAS, Article VII, Section 5 of the Declaration provides that the Declaration may be amended by the affirmative vote of at least seventy-five (75%) percent of Owners.

NOW THEREFORE, having obtained the required affirmative votes to amend the Declaration, Section (m) of Article 6, on page 14 of the Declaration is hereby deleted and replaced with the following:

(m) Prohibition Against Parking Trucks, Trailers, Boats and Other Immobiles on Lots. Unless located within enclosed garages, no boat, trailer, including but not limited to, house trailer, travel trailer, motor home, tractor trailer trucks, motorcycle trailers, boat trailers, or any other such vehicles, trucks or trailers shall be kept or maintained or located upon any Lot; provided, however, the Architectural Control Committee, at its sole discretion, may waive this requirement in any instance when an Owner presents to the Committee plans for permanent screening that the Committee finds aesthetically acceptable for the purpose of permanently screening the aforesaid vehicle(s), truck(s) or trailer(s) from view from all other Lots and from the streets that are within view of the Lot in question. The Committee shall have no duty to waive such requirement, but in the event it does, the Committee shall have the right to enforce the construction of the screening to conform to the plans that it approves. No vehicles that are disabled or under repair shall be kept upon any Lot unless located within enclosed garages. No Lot shall be used for storage of building materials prior to the issuance of the building permit for the Primary Residence.
